#### Parishioner's Issues

The dog bin in Ardley road requires attention or replacing.

As there have been a number of near misses on the road near the railway bridge – would it be possible to arrange for appropriate signage to be erected warning traffic of pedestrians in the road?

The leylandii outside Ardley House is encroaching onto the footpath and needs to be cut back. The verge by the woods is damaged and would it be possible for some of the chopped down trees to be used a seating in and around the wood?

Recently there has been a noticeable smell from Agrivert.

# Village hall/playing field committee

The council was asked for a grant/loan towards the cost of improvement works to the Village hall, as the s 106 money from the waterloo Homes development will not be available until later in 2021.

The Parish Council noted the circumstances and agreed to pay for the works, noting a possible voluntary donation from the village hall committee.

The Playing field committee is currently waiting for other estimates of the cost of work to the trees around the playing field.

#### The Fox and Hounds

Matthew Thame advised the meeting that the planning application had been changed to comprise 2 residential units and the shop/public house. CDC planners had indicated that it was likely that the application, being deemed to be infilling rather than conversion of an existing property, would be recommended for refusal under officer delegated powers.

The Clerk was asked to refer the matter to Cllr Corkin (CDC) noting the strong local support for the development.

#### **Potholes**

OCC have developed a new system for reporting potholes to which superusers will have access.
