1. Election of Chairman

Cllr Huw Jenkins was unanimously elected Chairman of the Parish Council for the year 2022/23.

3. Parishioner's Issues

There are plans to plant whips round the Quarry field in celebration of the Queen's Platinum Jubilee, but planting will not take place until the Autumn when the next supply is available.

It was reported that OCC have marked up potholes and carried out some repairs, but some remain un treated.

5. Minutes of the meeting of 14th March 2022

6. Councillor's reports

7. Progress on Parish matters

a) Strategic Railfreight Interchange.

The statutory consultation period has now started, and ends on 4th July 2022. The parish Council will be supplied with the details of the consultation which have been downloaded onto memory sticks. There will be a public consultation event in the Village Hall on 14th May. Should permission be granted the Parish Council would wish to see substantial support for the community, recognition that road links needed to be maintained and enhanced, an upgrade to junction 10 of the m40 and conditions limiting the effects of lighting and noise.

b) Traffic issues and Vas update

The VAS is working well. The Clerk was asked to purchase some "20 is plenty" signs, and advise OCC that the speed monitoring device on the B430 by the Church is not working.

c) Football Club

There has been no further request for support.

d) Jubilee celebrations

Details of events planned for the Jubilee Weekend will be circulated shortly. These will include children's games, fireworks a beacon and bunting.

e) Green/Environmental issues.

The Clerk was asked to request new signage for the footpaths around the Parish, as routes are not clear, and walkers are sometimes damaging crops unnecessarily.

f) The Chairman agreed to send log in details for the website to the Clerk.
