Minutes of the Ardley with Fewcott Parish Council on Monday 22nd May 2023 in the Norman Fraser Room of the Village Hall.

44. Election of Chair and Appointment of Vice chair

Cllr H Jenkins was unanimously elected Chair of the Parish council for the year 2023/24 and Cllr N Lewis was appointed Vice Chair.

45. Parishioner's Issues

A resident raised concerns about the condition of the grass in the Churchyard, and raised the issue of the disposal of green waste. It was agreed that the Parish Council would pay for 2 cuts of the Churchyard (in May and October) and the Clerk was authorised to buy a licence on behalf of the Church, to enable CDC to collect the waste from a brown bin. It was also agreed that the grass cutting contractor should be asked to cut back the nettles outside Ardley House.

The Clerk was asked to report safety concerns about the footpath at Church View, which has steps directly onto the road.

The Clerk was also asked to report the sinking manhole cover in Water Lane to OCC Highways, as it is a safety concern.

47. Minutes of the meeting of 10th March 2023

The Council agreed that the minutes of the meeting of the 10th March 2023 were an accurate record.

48. Progress on Parish matters

- a) Strategic Railfreight Interchange.
 - The Developers have written to affected parishes indicating that the application has been paused for a re-appraisal.
- b) Traffic issues
 - The Chairman has met with a representative of OCC highways, and is now waiting for proposals for traffic calming measures in the village. The condition of the B430 at the traffic lights by the new development has been reported, but concern was expressed that the damage to the surface is now exposing ducting for the lights.
 - The Parish Council has applied to OCC for the Village to be made a 20mph area, and it expected that the work will be carried out during this financial year. The Parish Council also agreed to push for part of the B430 to be included in the 20mph zone.
 - There are very large potholes by Ardley House.
- c) Green/environmental issues

Almost all the newly planted trees are flourishing, except an oak and a hawthorn, which will be replaced.

d) Viridor

Litter remains a problem along the verges of the B430. The Clerk will report the matter to OCC planning as the Parish Council believes lorries visiting the site are not sufficiently netted.
