# Minutes of the Ardley with Fewcott Parish Council on Monday 11<sup>th</sup> September 2023 in the Norman Fraser Room of the Village Hall.

#### 54. Parishioner's Issues

A resident raised concern about the speed of traffic approaching the village from Bucknell, and suggested that the road should be included in the current speed restriction review, and some identification of the start of the village (eg gates) might prove beneficial.

A resident thanked the Parish Council for the additional garden waste bin licences for the Parish Church, which will be holding a churchyard tidy up ( with soup for helpers) on 14<sup>th</sup> October.

The next Viridor Liaison meeting will take place on 5<sup>th</sup> October.

# 56. Minutes of the meeting of 10<sup>th</sup> July 2023

The Council agreed that the minutes of the meeting of the 22nd May 2023 were an accurate record.

#### 57. Councillor's Report

Cllr Simpson's written report has been circulated to Councillors. CDC are now consulting on the emerging Local plan, which should come into effect in 2025 and be effective until 2040. CDC are encouraging landlords to comply with their charter.

He also updated the Council on proposals for the Didcot relief road and new bridge over the Thames.

#### 58. Progress on Parish matters

a) Traffic issues

The Parish Council has received an initial consultation on proposals for a 20mph speed limit in the village. The proposals were broadly supported by the Council, although the Clerk was asked to raise again concerns about the speed limit on the B430 with OCC (which, under current proposals is to remain at 40mph. and to request that OCC consider the current speed limit on the approach to the village from Bucknell.

The Council will also be holding discussions with the developers Dorchester Homes, to gain improvements at the junction of the Bucknell Road and the b430, ideally with the junction controlled by traffic lights, as part of the development of the site at Upper Heyford.

b) Green/environmental issues The Council agreed the quote from Bicester Tree services in the sum of £762 to cut back trees and hedges in the village. There had been concern that an ancient oak tree in the village had been felled, while councillors recognised that it was not protected, the Clerk was asked to write to Sanctuary housing expressing the Council's disapproval.

- c) Viridor The liaison meeting will be on 5<sup>th</sup> October
- d) Mid Cherwell Neighbourhood Plan

The Convenor of the Mid Cherwell neighbourhood Plan attended to discuss with the Parish Council concerns about the allocation of 2 "Local Gaps" around Ardley to discourage sprawling development from Bicester. Councillors explained that they were concerned at attempts to control the use of private land that was currently farmed, but may need to diversify in the current farming climate. After discussion it was agreed that the parish Council could agree the extent and location of the "Local gaps" but required the plan to be amended to allow the land owner to have opportunities to diversify , while retaining, if possible, the current primary use. In subsequent discussion it was agreed to mirror the provisions in the draft Cherwell local plan ( to 2040) regarding diversification of farm activities.
